**III. WRT 2014 Budget Estimates and Tax Levies (Public Hearing)**

WRT Board Chairman Greg Rainbolt called the public hearing to order.

Trustee Mark Messick read to the public their legal rights and procedure to oppose the 2014 WRT advertised budget.

Mr. Messick stated the proposed budget for Township Fund 0101 is \$114,280 and \$50,100 for Township Assistance Fund 0840 for a total budget of \$164,380, he also said there was no tax rate or tax levy requested to meet the budget.

Mr. Messick reviewed the proposed 2014 WRT Budget with the WRT Board and the public in attendance section by section, there was discussion after each section relating to questions or concerns about the budget.

Jody Veldkamp and Dr. Dick Huber asked several questions during the public hearing about the budget but voiced no opposition to the budget.

Greg Rainbolt asked if there was anything else from the public and after hearing none he closed the public hearing.

Financial reports were distributed to the WRT Board by the Trustee.

Mr. Messick said applicant visits were down and there had been several cancellations, he noted that some potential applicants have been helped by charitable organizations.

Trustees in other townships in Johnson County said they were experiencing declines in applicant visits also according to Mr. Messick.

Greg Rainbolt said the WRT Board received a forwarded email sent to the Trustee from a disgruntled applicant. The original forwarded email was not read and applicants' name was omitted due to privacy concerns. The Trustees' email response to the applicants' complaint was read and also the email sent from Greg Rainbolt to the applicant.

Mr. Rainbolt stated that the public is always welcome to come to a public meeting and speak as long as they do so in a civil manner.


**V. Adjournment**
