**III. WRT 2015 Budget Estimates and Tax Levies (Public Hearing)**

WRT Board Chairman Greg Rainbolt called the public hearing to order.

The public hearing attendees were Trustee Mark Messick, WRT Board members Dave Pollard, Greg Rainbolt, and Peggy Young also present were WRT employees Mary Sue Kane and Mary Lou Habicht; no other members of the public were present.

Trustee Mark Messick and WRT Board members reviewed and discussed the 2015 WRT Budget Estimates and Tax Levies.

The proposed budget for Township Fund 0101 is \$124,150 and for Township Assistance Fund 0840 the proposed budget is \$51,200 for a total budget of \$175,350.

The proposed tax rate for Township Fund 0101 is 0.0066 and for Township Assistance Fund 0840 the proposed tax rate is 0.0020.

Mr. Messick reviewed the proposed 2015 WRT Budget with the WRT Board and the public in attendance section by section, there was discussion after each section relating to questions or concerns about the budget.

Greg Rainbolt asked if there was anything else from the public and after hearing none he closed the public hearing.

Board members and the Trustee had general discussions about township business.




