II. Approval of WRT Board Minutes (June 22, 2016 / August 09, 2016)

WRT Board Chairman Greg Rainbolt announced that there was going to be a change to the agenda and the WRT Board Minutes will not be approved tonight.

III. WRT 2017 Budget Estimates and Tax Levies (Public Hearing)

WRT Board Chairman Greg Rainbolt called the public hearing to order and announced Mary Sue Kane was going to represent Trustee Mark Messick due to his absence.

The public hearing attendees were WRT Board members Dave Pollard, Greg Rainbolt, and Peggy Young also present were WRT employees Mary Sue Kane and Mary Lou Habicht; no other members of the public were present.

Mary Sue Kane and WRT Board members reviewed and discussed the 2017 WRT Budget Estimates and Tax Levies.

The proposed budget for Township Fund 0101 is \$147,030.

The proposed budget for Township Assistance Fund 0840 is \$55,100.

The total projected 2017 WRT budget is \$202,130.

Township Fund 0101 will have a tax rate of 0.0039 to fund a tax levy of \$75,000.

Township Assistance Fund 0840 will have a tax rate of 0.0036 to fund a tax levy of \$70,000.

WRT Board members questioned the budget increase for repairs and maintenance during the public hearing, they stated their belief the increase would be lowered during the budget adoption meeting.

Greg Rainbolt asked if there were any other comments from the public and after hearing none the public hearing was closed.

Greg Rainbolt opened and Dave Pollard seconded a motion to open up the 2017 budget estimates for discussion amongst WRT Board members. Any concerns noted during the discussion will be addressed at the budget adoption meeting
