

WHITE RIVER TOWNSHIP BOARD MEETING
October 6, 2020

ATTENDEES: Mark Messick, Margaret Young, Dave Pollard, Dick Huber, Mary Sue Kane and Mary Lou Habicht.

GUESTS: Scott Blackwell and Greg Rainbolt

MEETING – Called to order at 5 p.m. by Chairperson Peggy Young followed by the Pledge to the Flag.

MINUTES – September 22, 2020 minutes distributed. Motion to approve minutes carried 3 - 0.

NEW BUSINESS –

1. **Current Year Financial Worksheet** provided by DLGF - Mark presented information to show that there are sufficient funds to support our 2020 budget for the remainder of the year.
2. **2021 Budget, Tax Levy and Tax Rate** - The proposed budget was presented initially at the September 22, 2020 board meeting, which included \$183,230 for the General Fund and Township Assistance Fund of \$56,750; for a total of \$239,980 (2020 Total Budget was \$179,180). Most line items remained the same or only slightly changed compared to 2020. See details in September 22, 2020 board minutes. The major change was \$60,000 for the required Capital Improvement Plan for 2021.
3. **Estimate of Miscellaneous Revenue, Budget Form 2** provided by DLGF – The estimated revenue for July 1 to December 31, 2020 is \$29,847; and \$43,541 for 2021. The major sources for miscellaneous revenue are local income taxes, vehicle excise taxes and rental of property.
4. **Budget Form 3, Notice to Taxpayers** – indicates that \$50,000 will be raised in tax levy for the general fund for a tax levy increase of 1.71% and \$0 raised in tax levy for the township assistance fund.
5. **Budget Form 4 and 4-B – Resolution for Appropriations and Tax Rates.** Proposed General Fund of \$183,230 and Township Assistance Fund of \$56,750 for a total of \$239,980. A tax levy of \$50,000 for the general fund would result in a Tax Rate of 0.0022. Motion made, seconded and carried for **adoption of 2021 Appropriations and Tax Rate.**



8. **Miscellaneous Business** – Mark reported for September - 2 appointments, \$0 for assistance and 16 times the community room was used.


